I - Introduction

On the 01th of June of two thousand twenty-six, at eleven hours and ten minutes, the jury nominated by the CCMAR board of Directors on 23/03/2026, met by video conference, for the forth meeting of the call Ref. CCMAR/BM/04/2026. The meeting was for the hiring of a Master's Fellowship (Bolsa de Mestrado), for applicants of any nationality, including stateless candidates, and holders of political refugee statute, in the scientific field of Information Technology. The jury present at the meeting was composed by Professor José Barateiro, Assistant Professor at University of Algarve (President); Professor Adelino Canário, President of CCMAR and Group Leader at CCMAR (Member) and Dr. Cristina Inácio, Director of Financial Services at CCMAR (Member) and had the following agenda items: final deliberation Following the Prior Hearing Procedure of call Ref. CCMAR/BM/04/2026.

II - Statement of no conflict of interests

We, the undersigned, fully understand the confidential nature of the assessment process and agree not to disclose or discuss its materials, nowhere, with no one, knowing the consequences of a misconduct.

We further declare that we have no direct or indirect financial, economic or personal interest that could compromise our impartiality and autonomy as members of this Jury.

Thus, we declare under word of honour that we will not evaluate candidates with whom we have a conflict of interest, for what we will require our immediate replacement.

III – Analysis of the Prior Hearing

The Jury appointed for the recruitment procedure above identified met to analyse the statements submitted during the prior hearing period.

Within the deadline established for the exercise of the right to prior hearing, one submission was received from a candidate. The candidate requested clarification regarding the reasons for the proposed cancellation of the call and enquired about the possibility of future fellowship opportunities.

The Jury analysed the submission and concluded that it does not contain any facts, arguments or evidence capable of altering the provisional decision communicated in Minutes No. 3.

The proposed cancellation of the call results from the fact that no candidate met the conditions required for the purposes of eventual selection, as stated in Minutes No. 3.

V - Conclusion

Therefore, the Jury unanimously decides to maintain the decision proposed in Minutes No. 3, namely the cancellation of the present call with no recruitment, and to submit this final decision for ratification by the CCMAR Board of Directors.

With no other item on the agenda, the meeting of which these minutes were drawn up was closed, with 2 pages, which after being read and approved were signed by the members of the jury.
